Contractor. If the Independent Contractor does not wish to make the requested changes, then University reserves the right to make those changes.

- 7. **Termination**: If services are not performed solely to the satisfaction of ASUCD, ASUCD may terminate this agreement immediately upon written notification to the Independent Contractor. This agreement may be terminated by either the Independent Contractor or ASUCD upon five (5) working days written notice to the other party of its intention to terminate and the specific termination date.
- 8. **Authorship Credit**: University reserves the right to determine when by-line will accompany the Work(s) in publication. Generally, feature articles and images published by University will be accompanied somewhere in the publication by a by-line, except in the case of articles, for shorter news pieces, and in the case of photographs, for head and shoulders "mug" photographs and copy-camera work. Such credit may be removed if Independent Contractor so desires due to changes made by University that are unsatisfactory to Independent Contractor.

9.	Ownership of Work(s): Except as otherwise specified below, ownership of Work(s) shall vest in University
	as stated in Article 3 above:

- 10. **Independent Contractor:** Both parties agree that in the performance of this agreement Independent Contractor will not be an agent or employee of the University and will not be covered by University's Worker's Compensation Insurance or Unemployment Insurance nor be entitled to any other University benefits.
- 11. **Indemnification**: The parties agree to defend, indemnify and hold one another harmless from and against any and all liability, loss, expense, attorney's fees, or claims for injury or damages arising from the performance of this Agreement, but only in proportion to and to the extent such liability, loss, expense, attorney's fee, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of the indemnifying party, its officers, agents, or employees.
